



AGENCY RETAINER FEE SCHEDULE

Client agrees to pay a fee to Agency for its services (“Agency Retainer Fee Schedule”). The Agency Retainer Fees are paid in several installments connected to significant milestone events in the surrogacy process. Each installment of the Agency Retainer Fees is fully earned at the occurrence of the milestone event and is not refundable.

The Agency Retainer Fee Schedule does not include any other charges, costs, or expenses or compensation to be paid to the Surrogate. All Agency retainer fees and expenses may be paid via check, money order, or wire transfer. There is an incoming wire transfer bank fee, as well as any bank fees on the Intended Parents end. There is also a 3% credit card convenience fee if a credit card is used for payments or if Agency is requested by Intended Parent(s) to use Agency’s credit card for payments for Gestational Carrier or Intended Parent(s).

Agency retainer shall be due and payable in accordance with the fee schedules herein.

FULL SERVICE FEE SCHEDULE: \$20,000

The Agency retainer fee is \$20,000. The Agency fees are due at the following times:

(1) Administrative Fee: \$3000

- The Administrative Fee is due upon execution of the Client Retainer Agreement and is non-refundable.
- Once a preliminary match is confirmed and prior to commencing medical clearance coordination, the Client shall tender a retainer of \$17,000 to be held in a Client Trust Account managed by Agency. All Client retainer fees are refundable up until the time that they become due. Once funds are in Client Trust Account, the Agency will pay Agency fees at time they are due from said account.

(2) Upon Clinic's Medical Clearance of Surrogate: \$8000

- This installment is due upon medical clearance approval of the Surrogate by the Client's fertility clinic.

(3) Upon Execution of Legal Agreements: \$8000

- This installment is due upon execution of the legal gestational surrogate agreement between the Client and the Surrogate.

(4) Week 12 of Pregnancy: \$1000

- This installment is due once the Surrogate has reached 12 weeks of gestation from date of embryo transfer.

Additional Agency Fees:

(5) Additional Embryo Transfers: \$600 per Embryo Transfer

- If the initial embryo transfer is unsuccessful, and additional embryo transfers are required with the same Surrogate, then Agency shall be paid per additional embryo transfer coordination, with payment due upon completion of said embryo transfer.

(6) International Parent Fee: \$1500

- This fee is charged to assist Parents to coordinate with insurance brokers for health insurance of the child while the child is in the US, and/or assistance with coordination with other agents, such as Passport Advisors, in order to obtain passport for the child.

(7) Home Study: \$1500

- Once Parents and their selected surrogate are ready to proceed with medical screening and/or legal contract, the home study fee will be due to Agency, and Agency will proceed with conducting a home study for the surrogate's home.

(8) Criminal Background Check: \$150 per check

- Once Parents and their selected surrogate are ready to proceed with medical screening and/or legal contract, Parents will be charged for criminal background checks for parents, surrogate, and surrogate's intimate partner/spouse.
